July 1922	Concluded a sales contract for lubricating oils with Vacuum Oil Co. under the name of Nihon Gyomo Sengu K.K.	April 1988	Opened Logistics Management Centers (Sapporo, Sendai, Tokyo, Nagoya, Osaka, West).
1929	Brand name "KYGNUS" was created.	November 1989	Nichimo Sekiyu Seisei K.K. changed its name to Kygnus Sekiyu Seisei K.K.
February 1935	Received authorization as an oil importer.	April 1990	Name of former Tokyo District Branch was changed to Kanto Branch.
October 1947	Designated as a distributor by the Petroleum Distribution Public Corporation.	July 1992	Kygnus Shoji K.K. was established.
April 1949	Received authorization as an oil primary distributor.	May 1996	Logistics Management Centers (Sapporo, Sendai, Tokyo, Nagoya, Osaka, West) were merged and located in Tokyo.
June 1951	Opened the first service station under the name "KYGNUS" at Isshiki-Ohashi, Nakagawa-ku, Nagoya-shi (present Isshiki-Ohashi service station).	October 1997	Names of former Sapporo Branch, former Sendai Branch, former Osaka Branch, and former Fukuoka Branch were changed to Hokkaido Branch, Tohoku Branch, Kansai Branch, and Kyushu Branch, respectively.
November 1958	Nichimo Sekiyu Seisei K.K. was jointly established by Nihon Gyomo Sengu K.K., Toa Nenryo Kogyo K.K. and Nippon Suisan Kaisha, Ltd.	Former Nagoya Branch, former Shizuoka Branch, former Hiroshima Branch, former Takamatsu Branch were merged and named Chubu Branch and Chugoku Shikoku Branch, respectively.	
October 1960	Nichimo Sekiyu Seisei K.K. Refinery was completed. Started selling the petroleum products produced there on an exclusive basis.	October 1998	Former Hokkaido Branch and former Tohoku Branch were merged and named North Japan Branch.
December 1960	Kygnus Kosan K.K. was established.	April 1999	Former Tokyo Branch and former Kanto Branch were merged and named East Japan Branch.
August 1963	Kawasaki Kygnus Sekiyu Hanbai K.K. was established.	October 1999	Name of Kansai Branch was changed to West Japan Branch.
February 1964	Kygnus Ekika Gas K.K. was established.	April 2000	North Japan Branch was merged into East Japan Branch, and Chugoku Shikoku Branch and Kyushu Branch were merged into West Japan Branch.
July 1967	Nagoya Oil Terminal was established.	July 2001	Tonen General Sekiyu K.K.(present JXTG Nippon Oil & Energy Corporation) and Kygnus Sekiyu Seisei K.K. were amalgamated.
April 1969	Ichikawa Oil Terminal was established.	December 2004	SAN-AI OIL CO., LTD acquired all of our shares that Tonen General Sekiyu K.K. (present JXTG Nippon Oil & Energy Corporation) and Nichimo Co., Ltd had.
